1. TERMS AND DEFINITIONS

- 1.1. **Company** "Sudo" LLC (TIN: 7801646991, Registration №: 1187847210407), responsible for the collection and all stages of processing personal data on the Website.
- 1.2. **Website** aggregate of logically connected web pages on the Internet at the address: https://ucp.academy/
- 1.3. **User** an individual using the Website and providing the Company with their personal data (personal data subject).
- 1.4. **Personal Data** any information directly or indirectly related to an identified or identifiable individual (personal data subject).
- 1.5. **Processing of Personal Data** any action (operation) or set of actions (operations) performed with or without the use of automation tools involving personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

2. GENERAL PROVISIONS

The Policy regulates the procedure for processing and using the personal data of Website Users in accordance with Federal Law No. 152-FZ of July 27, 2006, "On Personal Data".
